Dear Sigma Alpha Epsilon,

Based on the information presented and discussed, your organization, Sigma Alpha Epsilon Fraternity, accepts Responsibility for their actions, which constituted a violation of LSU's Code of Student Conduct, specifically:

10.2 Failure to Comply -- Responsible

As a result of the incident that occurred on October 20, 2020, where Sigma Alpha Epsilon Fraternity hosted a formal event out of town, your organization has submitted an Enhancement Plan. This will meet the requirements of the partnership process with Greek Life and Student Advocacy & Accountability:

Organization Disciplinary Probation

This accountability status will be effective February 12, 2021 through December 31, 2021. During this time, the organization will be required to complete outcomes and may forfeit certain privileges which may include, but is not limited to, loss or limitation of social events or inability to participate in University events or activities. Disciplinary probation will be reflected on the Student Organization Scorecard.

With respect to the information listed above, the following additional sanctions/stipulations apply:

- 1. The Chapter will not host any social events with alcohol prior to April 1, 2021 and after additional training has been completed as outlined in this enhancement plan.
- 2. All executive board members will attend SAE officer training and safe event planning by January 28, 2021. The Chapter will submit verification that this has occurred to SAA by March 1, 2021
- 3. Chapter will not host any out of town events prior to May 31, 2021.
- 4. The Chapter will send at least 5 members of the current executive council to SAE National Executives Academy by August 1, 2021. The Chapter will submit verification that this has occurred to SAA by August 15, 2021.
- 5. The Chapter will participate in LSU Greek week by supporting habitat for humanity by having 20% of each academic classification (Freshman, Sophomores, Juniors, Seniors) in attendance. The Chapter will submit verification that this has occurred to SAA by May 1, 2021.
- 6. The Chapter will amend the By-Laws to expand the Judicial Board from 4-8 members. The Chapter will also require bi-monthly meetings, with an advisor present, to address behavioral issues within the Chapter. Finally, all Judicial Board members will participate in LSU Judicial Board Training. These items will be completed by April1, 2021 with verification submitted to SAA by April15, 2021.

The following items will be completed by the deadline indicated and with verification of each item's completion submitted to Student Advocacy & Accountability using the <u>online reporting form</u> or via email to

The Enhancement Plan and Accountability Outcome will be kept on file in Student Advocacy & Accountability within the Office of the Dean of Students. The Enhancement Plan will also be shared with all relevant LSU and headquarters staff.
